- Site Visits: Guided tours to strategic locations offering tax incentives, modern infrastructure, and a regulatory framework conducive to business and foreign investment.

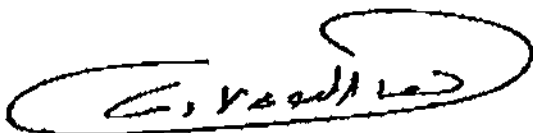
